RE: <u>EA1617-01 Tlicho All-season Road Draft Terms of Reference and Adequacy Statement</u>

Following the technical scoping session on August 24, 2016, the Mackenzie Valley Environmental Impact Review Board (the "Board" or "MVEIRB") distrubted Notice of Proceeding on September 19. The Notice of Proceeding outlined the process for producing a Terms of Reference ("ToR") for the Tlicho All-season Road project ("TASR" or the "Project"). On September 23, the Board distributed the draft ToR and Adequacy Statement for public review.

North Slave Métis Alliance ("NSMA") has expressed its concerns respecting the Project's impact on NSMA and its members' Aboriginal rights since it was first informed of the Project in mid-2015. NSMA's specific concerns and record of communication with the project proponent can be found on Wekeezhii Land and Water Board ("WLWB") and MVEIRB's Public Registries.

With above in mind, the NSMA reviewed the draft ToR and Adequacy Statement and provide following comments for the Board's consideration:

- NSMA is pleased to find that concerns we raised during WLWB's preliminary screening are considered and identified in the ToR and/or Adequacy Statement, including:
  - Heritage and cultural resources specifically relevant to NSMA<sup>1</sup>
  - Thorough investigation of cumulative effects<sup>2</sup>, including efficacy of mitigation options
- At this time, NSMA has no further item we wish to add to the draft ToR. NSMA trusts that, should additional concerns arise in the future, the Board will consider "all potentially
