I agree that some guidance is necessary on the minimum time allotted to allow for input on Guidelines/ToRs. What I have been doing the last two weeks is preparing two types of process flow charts. One where a developer is sent to EA and does not submit a fairly comprehensive environmental package at preliminary screening (draft EA), and one where a developer submits a fairly comprehensive environmental package to the preliminary screener (draft EA). I have tried to itemize all the activities and milestones involved in the EA process. The time between distribution and adoption of draft ToR is up there, as are a few other important items that need input just as you described. I wanted to get together with the core EA group from government to go over the charts and start detailing out the time lines for small e.g., Patterson EA's and medium to large EA's, e.g., BHP. I intend to do just that but am not sure if I should do it before a new ED is brought on line.
