The Conformity Consultation Period closes on **APRIL 9, 2002** not March 9 . After that, the Mackenzie Valley Environmental Impact Review Board (Review Board) will review all the submissions on conformity and either rule that the De Beers EA Report Conforms or is Deficient and issue a deficiency statement.

**Note:** *This conformity check determines whether or not De Beers has responded to what was asked for in the EA Terms of Reference; it does not reflect the technical adequacy of the information provided De Beers. Any additional technical information, or further explanation, required would be requested through information requests (IR's). IR's would facilitate the technical analysis of the development.*

I intend to consolidate the conformity submissions and prepare a briefing for the Review Board's next meeting. Thanks in advance for your patience and cooperation.
