As for the Technical Memo on NRCan's Issues that the MVEIRB recently received from De Beers, the MVEIRB will not file this information to the public registry at this time, and therefore the information will not be distributed to the parties to the EA. As per our April 2nd letter on Filing Requirements, it was requested that any documentation with respect to efforts of resolving issues should be filed by April 11th and 17th for De Beers and parties to the EA, respectively. These dates were set with a view to ensuring that parties had fair notice of information to be presented at the hearing. It is suggested that if you wish this information to be on the public record that the necessary information be reflected in your presentations/statements at the public hearing. It is noted, with permission of the Board, that some undertakings resulting directly from the public hearing may be filed to the public registry by May 23, the closing date of the public registry.
