

Louie: Thanks for the list - I have a few comments (Note I do not have all the addresses and emails handy). I am calling on the Diavik & BHP experiences as to which groups were actively involved or expressed an interest to be involved. I'm not too sure what the purpose of this list is - are you planning to distribute all materials related to the EA to this list? If yes you may want to contact each of the organizations and make sure that you have the correct contact name and that they are prepared for and wish to review all information. Some may just prefer to visit your web site - so I would check first.

You might also want to check (if you haven't already) with some of the folks listed here to find out if they are equipped to handle electronic submissions or if they require hard/faxed copies. I know that some communities/organizations sometimes experience difficulties with servers and downloading large files (especially if they have older computers they are working off of).
