I have no difficulty with any of the approaches being discussed. The choice made by a department participating in the EA to organize its work load and funnel contacts with the department is an internal matter. The only requirement should be that the preferred approach is clearly communicated by the department in question. The question of the expertise of those offering opinions and professional judgements to the MVEIRB is, however, a different issue.

I suggest that there must be some indication of the expertise which will be brought to bear on the technical issues by the participating departments. This should include both the name and the CV of the expert(s) to be used by the department. How contact with these experts is made is for the departments to decide.
