Summary of Meetings and Interviews Held Between March 1999 and March 2003

Each of the primary communities has been visited on several occasions throughout the SEIA process, and a cross-section of community members has had an opportunity to provide input during each of those visits.

Table 1.1, below, identifies the number of in-person interviews conducted with communities and organizations between December 2000 and June 2002.

The following table shows that 93 in-person interviews were conducted with the 6 primary communities and organizations. Community visits, for the purpose of interviews, were typically 2-4 days in duration. Semi-structured interviews were used and they lasted between 30 minutes and 1 hour. The purpose of the interview was to discuss issues, concerns and experiences with a cross section of people including, Official leaders (Chiefs, councilors), First Nations Staff (administrators, economic development coordinators, outreach coordinators, finance officers, social services and health workers, literacy coordinators), mine workers, spouses of mine workers, a community nurse, youth and Elders.

Table 1.2, below, identifies the number of in-person meetings and site visits with communities and organizations between March 1999 and May 2001.

The following table shows that De Beers visited the 6 primary communities on a regular basis to conduct 49 community meetings. Information on the project was provided to communities through power point presentations, verbal description, and open house meetings. These meetings also held a consultation component, so that De Beers could have discussions with a cross-section of the community residents to determine the key socio-economic issues and concerns with regards to the Snap Lake Diamond Project.

The following table shows that De Beers conducted an additional 53 in-person interviews in the 6 primary communities to introduce, discuss and develop the impact management measures. De Beers will continue to consult with the communities on the future development of the IMM.

In total, 93 interviews and 38 meetings were held to develop the SEIA that is contained in the EAR. Since the submission of the EA Report, an additional 52 interviews have been held to further the SEIA work.
