On August 9, 2002 the Mackenzie Valley Environmental Impact Review Board's (Review Board) consultants advised the Review Board to issue a number of wildlife related Information Requests (IR). Unfortunately, these questions were inadvertently not included in the Round 3 IRs and did not make their way to De Beers. The Review Board would still like to have these questions answered, preferably before the Technical Workshops scheduled for late November and early December 2002.

The Review Board is not reopening the IR component of the environmental assessment as a result of this action.

De Beers may respond to the Board IRs before the technical sessions or the company may provide its responses in the technical workshops. Regardless of the timing of the response, the Review Board requires written responses to these questions in a format consistent with other IR responses.
