Subject: RE: Ruling on Request to Keep Public Registry Open on Snap Lake EA

With respect to my previous email on Kevin O'Reilly's question surrounding the closing date of the public registry (see below), I would like to provide further clarification.

The Review Board responded to NSMA's May 6th request to extend the closing date of the public registry in consideration of the Elder's Caribou Workshop. In the Review Board's May 22nd letter, it outlines that the closing date of the public registry will not be extended. This is consistent with the Chair's hearing statements of May 1st regarding the decision not to file the results of the workshop on the public registry.

On the matter of making an amendment to the scheduled closure date of the public registry to allow for the filing of the socio-economic agreement and environmental agreements prior to the issuance of the Report of Environmental Assessment, the Board will be meeting early next week to make a decision on this. For the time being, the public registry is considered closed as of Friday May 23rd, 2003. I am advised by legal counsel that the public registry can be re-opened if need be.
