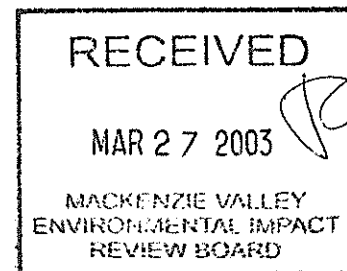

Social/Cultural/Economic Themes


We also anticipate making an opening and a closing statement. At this time we anticipate that our presentations will be given by:
