THE SOCIO-ECONOMIC IMPACTS OF DIAMOND MINING: LEARNING FROM THE LUTSEL K'E COMMUNITY-BASED MONITORING

The survey that we are reporting on is part of a larger community health monitoring project that began in Lutsel K'e in 1996. The study was funded by the West Kitikmeot Slave Study Society. Indicators were developed based on interviews with each household in the community. A qualitative and quantitative survey was developed to monitor many different kinds of indicators about self-government, healing and cultural preservation. The other people who have worked on this project in the last seven years are Angie Lantz, Evelyn Marlowe, Dennis Drygeese and Bronda Parloc. Dr. John O'Neil from the Aboriginal Centre of Health Research at the University of Manitoba, helped us develop this survey so that we could be confident about they way that we asked the questions and about interpreting the results. (See attached Community Based Monitoring Ouestionnaire).

In addition to this larger health monitoring questionnaire, we have done qualitative research on the impacts of mining employment. The survey results we will present today are from 2001 qualitative semi-directed interviews with mine employees and their families. These results tell you about the quality of the employment (based on the experiences of the employees) and how this employment has affected families in our community. We focused on families because that is the impact that employees have talked about the most.

Definition

When we are talking about the mining sector, we are mainly talking about employment with the existing Ekati and Diavik diamond mines. Of the 20 people we interviewed, over half of them were employed full-time (60%). Part-time, casual and seasonal jobs represented only 15% of the employment.

Quality of Employment

We asked the mine employees - What do you like about your job?

- Teamwork (31%)
- Training and skill development (28%)
- Enjoy the Work (Tasks) (18%)

Another question was - How could your job be improved?

- Better work schedule (23%)
- Better teamwork (17%)
- Unknown/Nil (15%)
- Child Care in the Community (13%)

Go H We also asked the mine employees - If you are no longer working, why did you leave your job?

- Family problems (30%)
- End of Contract (25%)
- Still Working (20%)
- Too few Aboriginal People (5%)
- Health Reasons (5%)
- Did not like the work/place (5%)
- Perceived Racism (3%)

We also talked to families about the Impacts of Employment on the Family We asked them - How has the employment benefited the family?

- Help pay bills on time / groceries (59%)
- Income for skidoo, boat, quads, vehicles, furniture (23%)

We also asked - Is work affecting your family? How?

- No (30%)
- Breakdown of Relations with Children (27%)
- Not enough time with Children (23%)
- Increasing responsibility and pressure on spouse (14%)
- Breakdown of relationship with spouse (7%)

In summary, the results of the survey tell us about the importance of family in our community. These results also tell us that mining employment may be negatively affecting family life. In order for our community to benefit, rather than be negatively affected by the proposed De Beers diamond mine, we recommend the following:

Family time: Employment in the mining sector creates stress within the family. The 2 week rotation schedule separates parents from their children and spouses from each other. Our research has revealed many different emotional, mental as well as physical health problems resulting from this separation. De Beers Canada should work with mine employees as well as health and social service resource people in our community to help mitigate these effects. (See presentation by Lutsel K'e Health and Social Services)

Investment in Day Care: The Government of the Northwest Territories is responsible for funding education in our region. Childcare for children under school age is a major issue. If employees do not have responsible childcare, it creates stress and anxiety in them as an individual and in the family. They are more likely to miss work or quit their job for that reason. For our community to benefit from the proposed De Beers Diamond Mine, further work must be done to ensure.

Time "On the Land": The other major impact of the diamond mining industry relates to traditional land use. Our community is based on a land-based way of life — caribou hunting, fishing, berry harvesting and trapping. The land is part of our identity. Employees working at the diamond mines report spending less time on the land (and their

families) than do other members of our community. This can be cause for emotional stress and anxiety.

Conclusion:

Many of the health issues we have talked about are not about physical illnesses – they are issues of emotional stress and anxiety. There is no outward sign that employees and their families or other members of our community may be suffering. However, emotional stress and anxiety can lead to many other social problems and physical health effects in our community. These impacts may not be visible today or tomorrow – but maybe next year or in five years. Children growing up without safe childcare facilities and the absence of one or more parents will surely have devastating impacts on our community in the future. By sharing this information with you today, we hope that you will consider how the Government of the Northwest Territories, the Government of Canada, De Beers Diamond Mine as well as the other mines can help us deal with these health issues before we see a health crisis in our community.













How is this schedule affecting the family?








- * Breaks are good




- The employments at the mines help pay bills on time also provides groceries. (59%)
