

## Re: Meeting with Ka'a' Gee Tu First Nation

I am now instructed to set up a meeting between you and our client.

I have canvassed Mr. Landry and the other representatives for the Ka'a' Gee Tu First Nation, and they are all available to meet with Paramount on March 8. As one person is located in Calgary, and we will be coming from Vancouver, it would be most economical to hold the meeting in Calgary.

Please also confirm that, as Mr. Landry has understood, Paramount does not intend to restrict this meeting to the narrow issue of developing a plan to provide damages for loss of income due to impacts on trapping and hunting.
