Environmental Protection Plan Information Request Clarification

Further to Paramount Transmission Ltd.'s ("PTL") response dated February 10, 2002 regarding the Environmental Protection Plan ("EPP") for the above project, PTL hereby submits a further revision of page 16 of Section 2 of the EPP to clarify the authority of the Heritage Resources Monitor from the local communities.

The fourth bullet of the section on page 16 titled, "Heritage Resources", been revised as follows (revision shown in bolded italics):

• "The Heritage Resource Monitor may request the Paramount inspector to stake and mark the area of the discovery and issue a stop work order for the area if *the Heritage Resource Monitor* determines that the discovery is a heritage resource."

This revision is consistent with PTL's response to information request (c) of the National Energy Board's ("NEB") letter of February 8, 2002. PTL's response is attached below for reference.

Response:

The heritage resource monitor can request the Paramount Field Supervisor to declare a discovery a heritage resource. The Paramount Field Supervisor will then issue a stop work order, flag or stake the area, and summon an archeologist to consult with the heritage resource monitor and/or the local communities to confirm the discovery. Mitigation measures will be developed in consultation with the heritage resource monitor and/or the local communities.

Page 16 of Section 2 and page 31 of Section 4 of the EPP has been revised to clarify this process.
