Peter: Here are the GNWT's comments on the draft T&Cs for Paramount.

First, as we discussed on the phone, there is no need for a condition requiring Paramount to discuss mitigation for rutting with the GNWT. We are satisfied if you keep conditions 34, 35 and 36 as proposed in the draft permit, or something to that effect.

With respect to windrows, we are satisfied with the proposed condition of seven meter breaks every 330 meters. However, we would like additional conditions requiring Paramount to create additional breaks in windrows/snowrows wherever the right of way crosses a known or obvious game trail or any other crossing (i.e. old seismic lines, since wildlife like to travel down these lines). Paramount has already committed to doing so in their EA document. In addition, we would like to have the option of altering the windrow/snowrow length and break width in order to investigate the effects of different lengths etc. on wildlife movement (we are considering doing a study on this as part of the wildlife monitoring program, but nothing is definite yet. We just want to keep the option open).

Hi Brett,

Just some EA recommendations that I want to get clarified with the GNWT:

EA#2 - DIAND Inspector recommended condition for rutting:

"33. The Permittee shall prepare the site in such a manner as to prevent rutting of the ground surface as directed by an Inspector.34. The Permittee shall suspend overland travel of equipment or vehicles if significant rutting occurs or as otherwise approved by an Inspector.

EA#9- We have drafted up this condition;

The Permittee shall develop and implement a wildlife monitoring program in consultation with EC and the GNWT and will submit the proposed wildlife monitoring program to the Board for approval within 90 days of project commencement.

EA#10 - DIAND Inspector recommended condition:

"The Permittee shall dispose of all debris cleared from rights-of-way, quarry/borrow sites and staging areas by:

- (a) windrowing the debris and brush to the side of the line or clearing and on the rights-of-way; and
- (b) making breaks in the windrow of at least seven (7) metres wide at intervals of not more than three hundred and thirty (330) metres."

EA#19-21- Incorporated these recommendations and some others into two generic catch all conditions;

The Permittee shall conduct the operation, perform the mitigations and remedial measures, and hold consultations with government agencies and aboriginal communities as outlined in Attachment 1 to the Mackenzie Valley Environmental Impact Review Board's Report of Environmental Assessment on the Paramount Resources Ltd. Cameron Hills Gathering System and Pipeline Development

The Permittee shall adhere to all commitments as outlined in Attachment 2 to the Mackenzie Valley Environmental Impact Review Board's Report of Environmental Assessment on the Paramount Resources Ltd. Cameron Hills Gathering System and Pipeline Development.EA#19-21
