Imperial Oil Resources Ventures Limited (Imperial), on behalf of the Mackenzie Valley Aboriginal Pipeline Limited Partnership, ConocoPhillips Canada (North) Limited, Shell Canada Limited and ExxonMobil Canada Properties, encloses 21 copies of the Developer's Assessment Report prepared in support of an environmental assessment being conducted by the Mackenzie Valley Environmental Impact Review Board (MVEIRB). In addition, a copy has been sent directly to each of the 39 interested parties listed in the attachment to this letter. Electronic versions of the Developer's Assessment Report have been sent to all parties under separate cover.

The environmental assessment relates to the applications by Imperial to the Mackenzie Valley Land and Water Board (MVLWB) for a Land Use Permit (MV2003X0045) and a Water Licence (MV2003L8-0012). These two applications would permit certain activities associated with the 2004 Winter Field Geotechnical Investigation Program - Deh Cho Region (the program).

The proposed program will consist of activities at 69 sites; 46 potential borrow sites, eight water crossing sites, ten frost heave sites, and five rig camp sites. The objective of the program is to gather information for an assessment of the soil and ground conditions along a potential pipeline right-of-way. The information obtained from the program will be used in the engineering and construction studies for a pipeline in the Mackenzie Valley and for preparing subsequent regulatory applications. The program was originally proposed for the winter of 2003/2004. It is now proposed for the winter of 2004/2005.
