Re: Community Concerns regarding Imperial Oil Resources Ventures Ltd Geotechnical Field Investigations

As you are aware, the Mackenzie Valley Environmental Impact Review Board (MVEIRB) is conducting an Environmental Assessment due to public concern about the above development. The MVEIRB will accept responses until 5:00 pm on Friday April 2nd, 2004. It will consider your responses, and will then release a draft Terms of Reference and Workplan for public comment.
