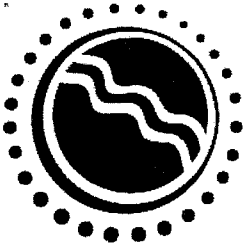

You are hereby notified that the Pine Point Pilot Project proposed by Tamerlane Ventures Inc. has been referred to the Mackenzie Valley Environmental Impact Review Board for environmental assessment, pursuant to subsection 126(2)(a) of the *Mackenzie Valley Resource Management Act*. The proposed project is to use underground mining methods to extract, separate and provide transport for a 1,000,000 tonne bulk sample from the Pine Point site 48 km east of Hay River. The project was referred to the Review Board by Environment Canada on June 27, 2006.

As per the requirements of MVRMA s.118(1), no license, permit or other authorization for the carrying out of this development may be issued under any federal or territorial law until the completion of the environmental assessment.

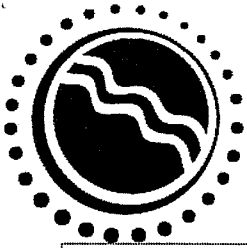
