Thank you to the Review Board for hosting the pre-hearing conference yesterday for the Giant Mine EA. The purpose of this e-mail is to confirm a number of commitments made by Alternatives North and other parties. Please post this e-mail to the public registry.

Information Required Prior to Hearing (preferably by August 10 and not all at once)

- 1. Freeze Optimization Study trade-off study (lessons learned) and description of the development of performance criteria
- 2. Arsenic chamber wetting study progress report
- 3. Best Available Technology (BAT) findings for water treatment evaluation
- 4. AANDC organizational charts for the Giant Mine Remediation Plan (including location of position), for both project implementation and the perpetual care phase
- 5. Risk Assessment for Ingraham trail users study based on exposure to redicted air quality standard exceedances
- 6. Updated project cost estimates with Baker Creek costs split out
- 7. AANDC Northern Contaminated Site Program report on document preservation and information management
- 8. Tailings cover objectives and design update
- 9. Site Stabilization Plan as approved by the AANDC Minister in November 2011

We understand that AANDC/GNWT as the Developer will provide an updated list of commitments made to date and a table that lists and shows its responses to each recommendation (measures and suggestions) made by the parties that have submitted Technical Reports on time. This is to be filed with the Review Board on or before August 10, 2012.

On or before August 22, Alternatives North will file our presentations for the public hearing along with resumes for any experts we expect will participate at the hearing. We would like the same information from the other parties.

Please be advised that Alternatives North intends to question AANDC/GNWT as the Developer on the following topics. The time we require is somewhat dependent on the additional information requested above by August 10 and the possible responses to the measures and suggestions made in our Technical Report. Estimates are provided below for planning purposes:

- 1. Surface (30 minutes)
- 2. Freezing/Underground (45 minutes)
- 3. Water (45 minutes)
- 4. Risk, Monitoring, Management and Perpetual Care (60 minutes)

Alternatives North would like to question the City of Yellowknife and Environment Canada (with regard to the policy context for perpetual care of site remediated under the Federal Contaminated Sites Action Plan) and would like to make sure these parties are at the public hearing.
