Alternatives North is still awaiting the Structural Conditions of Roaster Complex report requested on June 12, 2012 in the e-mail below.

In addition, as time did not allow at the June 27-28 technical meeting, Alternatives North would like to know whether AANDC still intends to pursue an exemption of the Roaster Complex from the ongoing Environmental Assessment. If AANDC pursues such a course of action, Alternatives North would like a schedule for the work to be done (e.g. contracting schedule, dates for commencement and completion of the work) and the legal justification to be filed with the Review Board at the same time as any request or notification of exemption. We also seek a firm commitment from AANDC that it will retroactively apply any and all applicable recommended remedial measures and suggestions from the Review Board to the Roaster Complex demolition should an exemption be pursued. We look forward to your reply to these matters in advance of the July 11, 2012 filing deadline of our Technical Report. Thank you.
