An independent funding review committee (the Committee) has completed its review of applications for participant funding for the Giant Mine Remediation Plan. The Committee met the week of January 10, 2011 and submitted its recommendations to me in a letter dated January 14, 2011. The Committee's recommendations are enclosed.

I am satisfied that the Committee's recommended allocations will provide the best value to the Board's review of the Giant Mine Remediation Plan. I accept the recommendations of the Committee and am pleased to award the following amounts to the successful applicants:

1.	Alternatives North	\$86,380
2.	North Slave Métis Alliance	\$42,990
3.	Yellowknives Dene First Nation	\$120,630

This funding is contingent on each party being able to enter into and meet the requirements of a contribution funding agreement with the Department.
