Hey Adrian.

Can you clarify what you are saying with this note? I'm not clear that it's either necessary or appropriate as the DAR conformity check is not yet complete. Are you concerned that the IR round would start in 2010? Surely it isn't that the Board would delay something over a year to 2012?

From the Lands perspective, we're expecting the IR phase to kick in 2011. We are hopeful that the Board is aware of:

- a) the time requirements for a small office to review several hundred (thousands? I haven't looked at the appendices) pages of the DAR amongst other duties. We do not have a team of people standing by. We have one guy.
- b) that the Board is sympathetic to the administrative time demands that routinely kick in with small offices during the March-April (year end) period and that the subsequent stages of the process will take that into account
