Safety Achievement

Welcome to the spring edition of our community newsletter, as we look forward to longer days and warmer weather ahead.

I want to take this opportunity to congratulate our teams at the Ekati mine on a recent impressive safety achievement.

During the last fiscal year, we achieved one of the best safety performances in several years.

One of the ways we measure safety is through the All Injury Frequency Rate (AIFR), which includes lost-time injuries, restricted work duties, and medical treatment cases. Last year, the Ekati mine achieved an AIFR of 0.77, which is a significant improvement over the previous year.

We are extremely proud of this achievement, which could not have

happened without the commitment of all our employees and contractors, both at the mine site and in our Yellowknife operations.

We remain committed to our safety culture, which enabled us to reach this important milestone.

As you enjoy the changing season, we want to remind everyone to be aware of your personal safety and look out for the safety of your family, friends, and colleagues.

As we like to say at Dominion, safety is not about protecting you **from** something, it's about protecting you **for** something.

Jay Project Update

The Jay Project is continuing to progress well, with the permitting process still underway.

Dominion has filed updated water licence and land use permit applications, which is the next step in the environmental approval of the project.

Public hearings took place for the licence applications in Yellowknife in December, with strong participation from a variety of community groups.

The next steps involve the ongoing review of the draft water licence, with

a decision by the responsible Minister thereafter. Dominion believes the mine life extension provided by Jay positions us well for the future.

There is ongoing engagement with the communities through the Traditional Knowledge Elders Group (featured on page 3), leadership tours, and meetings on specific aspects of the project, e.g. fisheries impacts and offsetting.

Fisheries Offset Project

What is "Fish Offsetting"?

"Offsetting" involves replacing fish that were lost from a particular area as a result of development.

According to the Department of Fisheries and Oceans, "offsetting activities support and enhance the sustainability and the ongoing productivity of fish that are part of, or support, a commercial, recreational or Aboriginal fishery".

Dominion Diamond has undertaken a series of meetings in the communities to discuss options for a fisheries project for inconnu fish, also know as coney.

Traditional Knowledge holders indicate that both coney and whitefish once lived and reproduced in the Yellowknife River. Whitefish continue to thrive there today, but coney disappeared in the mid 1900s.

Dominion would like to reintroduce coney into the Yellowknife River to fulfill requirements for fisheries offsetting for the Jay Project.

The company has been working with the Department of Fisheries and Oceans (DFO), as Dominion is required to apply for a Fisheries Act authorization for the Jay Project.

We have been working on the development of an Offsetting Plan,

which will be submitted to DFO.

DFO was invited to attend the community meetings, which have taken place with the North Slave Métis Alliance, the Fort Resolution Métis Council, the Kwe Beh Working Group, the Yellowknives Dene First Nation, Deninu Kue First Nation, and in the communities of Behchokò, Whatì, Gamètì, Łutsel K'e, Wekweètì, and Kugluktuk.

Dominion has been collecting data from the Yellowknife and Cameron rivers every year since 2014 to better understand how to re-establish the population of coney in that area. The data includes:

- Habitat (river and water characteristics)
- Spawning locations and timing
- Egg locations

Dominion wants to continue working with the communities to investigate other options for fisheries offsetting that might complement or provide a contingency for the coney project, including local fish habitat enhancement projects.

Dominion Diamond established the TK Elders Group to gather information that will be aligned in planning and decision-making at the Ekati mine. This was one of the measures in the Report on the Environmental Assessment for the Jay Project.

Although the focus is on the Jay Project, the knowledge gathered may be applied to the Ekati mine site to further mitigate impacts on caribou, water, land, air and fish as outlined in the Terms of Reference.

Trail Blazers Project in Lutsel K'e

Congratulations to the Trail Blazers crew in Lutsel K'e, who worked hard last summer to make areas outside of the community more accessible to residents and tourists. In particular, the group cleared the traditional

trails to Lady of the Falls. The brushcutting projects provided access to historical locations for picnics, biking, quading, walking and sightseeing. The project created short-term employment opportunities in the community and reinforced the importance of safety awareness in a job setting.

Dominion supported the project by providing safety equipment, including safety vests, hard hats, safety glasses, gloves, and steel toe boots. This is in line with the company's commitment to promoting a safety culture.

The Trail Blazers participants took safety and training courses which could be transferrable to other employment opportunities.

Dominion also provided money towards the feast to celebrate the safe completion of the project.

Safe Day Everyday Gold Award

Dominion Diamond has received the Safe Day Everyday Gold Award from the Association for Mineral Exploration BC and Prospectors and Developers Association of Canada (PDAC) for the second year in a row.

The award was presented for the highest number of hours without a lost time incident in 2015. During the exploration phase at the Jay Project and Sable Project, a total of 468,000 hours were accumulated by employees with Dominion and seven contract companies – Major Drilling, Foraco Canada, Golder Associates, Aurora Geosciences, Nuna Logistics, Advanced Medical Systems, Ross Industries, and McCaw North.

Access to the two exploration areas was enabled through the construction of winter ice roads by Dominion crews at the Sable Project, and Nuna Logistics crews at the Jay Project.

Last year, Dominion received the award for completing a largescale drilling program at the Ekati Diamond Mine in 2014 with zero recordable injuries.

CEO Brendan Bell said, "I am extremely proud of our team at the Ekati mine for maintaining such a high commitment to safety. It is through the dedication of our contracting companies and their commitment to safety that we earned this achievement. This is a reflection of the importance we place on safety across all aspects of our operations."
