<u>Dominion Diamond Ekati Corporation Jay Project Environmental Assessment (EA1314-01) – Participation of the Government of the Northwest Territories at Community Hearings</u>

In response to your letter dated 21 Aug 2015, regarding the Government of the Northwest Territories' (GNWT) participation at the community hearings scheduled for Dominion Diamond Ekati Corporation's (DDEC) Jay Project, the GNWT provides the following information.

The GNWT is committed to continued participation in the Jay Project EA. The GNWT recognizes that community hearings provide an opportunity for the Board to gain an understanding of concerns relating to the project directly from potentially affected individuals, communities and Aboriginal organizations. GNWT has and will continue to monitor any such concerns throughout the entirety of the Board's process.
