WORK PLAN

On May 22, 2014, Canadian Zinc Corporation's (CanZinc) proposed Prairie Creek all season road and airstrip project was referred to the Review Board by the Mackenzie Valley Land and Water Board for an environmental assessment (EA). The Review Board released its final Terms of Reference on September 12, 2014. CanZinc submitted its Developer's Assessment Report (DAR) on April 23, 2015.

Below is a summary of the key dates for the EA. Future dates will be re-evaluated after key milestones in the EA process. The dates depend on the information provided at each step. If the information provided is insufficient for the EA to proceed, the process may be delayed.
