Hi Sachi,

I have reviewed the section 4.4 of the DAR Addendum a coordinate or road km marking is not provided in the description, so my response may not be accurate. I have flown over this area several times and a linear clearing can be seen from the air near km 105 of the original winter road alignment.

The eastern park boundary ends at km 100 of the winter road. It is possible that the Wolverine airstrip referenced in section 4.4 of the DAR Addendum is the same linear clearing at approximately km 105, and if this is the case the Wolverine airstrip is outside of the park. I hope this helps.
