Participation and status of territorial departments in the environmental assessment for Diavik's proposed deposition of processed kimberlite in pits and underground [EA1819-01]

I am pleased to provide the anticipated Government of the Northwest Territories' (GNWT) departmental participation in the environmental assessment of Diavik Diamond Mines Inc.'s proposal to deposit processed kimberlite in pits and underground [EA1819-01].

The following table provides a summary of the primary relevant roles and expertise within the GNWT that are applicable to the above noted environmental assessment. Please note that this summary is subject to adjustment as the environmental assessment proceeds. The Department of Lands will continue to inform all other GNWT departments of the environmental assessment process; these departments will increase their active participation should topics relevant to their mandates emerge during the proceedings.

Lands	 Will coordinate the GNWT's participation in the environmental assessment.
	Will provide specialist advice and be involved in the environmental assessment processes regarding the management and administration of the sustainable use of territorial land, including land use and sustainability standards, guidelines, and policies.
	Will manage land tenure requirements as applicable.

Department of:	Role
Environment and Natural Resources	 Will be involved in the environmental assessment processes and will provide specialist advice related to topics such as wildlife and water quality, based on the Department of Environment and Natural Resources' mandated authority and responsibilities as per relevant acts and regulations. Will continue to perform its duties as the GNWT lead for the Diavik Diamond Project <i>Environmental Agreement</i> of March 2000.
Industry, Tourism and Investment	 Will provide specialist advice and be involved in the environmental assessment processes on economic development, including natural resources, parks, business, and trade and investment. Will continue to perform its duties under the <i>Diavik Diamonds Project Socio-Economic Monitoring Agreement</i> of October 1999.
Health and Social Services	 Will provide specialist advice and be involved in the environmental assessment processes with respect to the evaluation of environmentally- and socially-mediated impacts of industrial projects on the health and social well-being of peoples of the NWT. Will provide expertise on compliance with the <i>Public Health Act</i> and its regulations and what potentially constitutes a public health hazard.
Justice	Will provide legal advice to the GNWT.
Executive and Indigenous Affairs	 Will provide specialist advice to the GNWT on the duty to consult Indigenous governments and organizations. Will provide specialist advice to GNWT departments respecting the negotiation and implementation of Aboriginal rights agreements.

I have also attached the GNWT's application for party status. The GNWT will participate fully in the environmental assessment processes including asking and responding to any information requests, participating in public and/or technical hearing(s), and providing an intervention and closing argument, as invited to do so by the Mackenzie Valley Environmental Impact Review Board (Review Board). If the Review Board or another party requires information from a GNWT department for the environmental assessment, the Project Assessment Branch in the Department of Lands should be contacted and will coordinate the GNWT responses.

Along with providing expert advice and responding to questions, various GNWT ministers will be responsible ministers under the *Mackenzie Valley Resource Management Act* (MVRMA) for this environmental assessment. The GNWT will make a final determination regarding which ministers are responsible ministers after the Review Board issues its Report of Environmental Assessment and Reasons for Decision. The GNWT responsible ministers will work closely with federal responsible ministers to fulfill their statutory decision-making responsibilities based on the relevant evidence provided during the environmental assessment. As this project is wholly on territorial land, the GNWT's Minister of Lands has the delegated authority to sign any required decision letters under section 130 of the MVRMA.
