# Résumé of Marc G. Stevenson

Marc Stevenson has for over 20 years worked with Aboriginal groups, universities, governments, NGOs and industrial proponents on a broad range of issues affecting Aboriginal communities across Canada. Marc has had diverse and varied career in the field of anthropology, blurring the boundaries between theoretical and applied research. In the late 1970s and early 1980s Marc was a major contributor to international debates on how archaeological sites and ethnic groups are formed, publishing in such leading journals as the Journal of Anthropological Archaeology and American Antiquity. Marc's work among the Inuit in the 1980s led to research outlining the structure of Inuit social organization, which was subsequently published by Oxford University Press. Over the last decade, Marc's research interests have shifted towards issues of traditional ecological knowledge, co-management, economic development, social and environmental impact assessment, and Indigenous rights. He is currently in the process of publishing and preparing a number of papers and books on these subjects. Although Marc still retains a foot in the consulting world (mainly in Nunavut and the northern territories), most of his time is spent as Aboriginal Program Manager of the Sustainable Forest Management Network, University of Alberta, where he works closely with Dr. Cliff Hickey, the National Aboriginal Forestry Association, and numerous First Nations communities, while advising a number of graduate students.

Marc's diverse experiences, combined with a PhD in anthropology, masters degree in archaeology, as well as excellent oral and written communication skills have allowed him to address, in an innovative manner, many of the environmental, social, political, economic and cultural issues and challenges facing Canada's First Nations, Inuit and Metis peoples. Marc has developed considerable expertise in and knowledge about the linkages among environment, society and economy in Aboriginal communities. He is particularly noted for his research on traditional knowledge, indigenous management systems, co-management, traditional economy and sustainable development. Marc remains committed to balancing society's, government's and industry's needs with those Aboriginal peoples, and to fostering opportunities for Aboriginal communities to facilitate their own social, economic, and political development. Marc is a Research Associate with the Canadian Circumpolar Institute, a former instructor with the Department of Canadian Studies (University of Alberta), a former instructor with Banff Centre for Management, and a former director of the Independent Environmental Monitoring Agency for the BHP diamond mine. In addition to being the author of scores of publishable quality "grey literature" reports, he is the author of numerous key recent and forthcoming publications, including:
