

The Northwest Territory Métis Nation (NWTMN) would like to advise Paramount Resources that your request for an RSVP to an information session on August 13, 2003 was the first contact we have had regarding this matter. A review of our files would indicate that no correspondence was previously received regarding this information session. The NWTMN is very concerned that this recent lack of communication maybe an indicator of future dealings between our organizations. We would encourage your company to make every effort to deal directly with NWTMN staff to avoid a repeat of this oversight in the future. As you may recall NWTMN staff had previously, during an open house session in Hay River, provided you with our business cards. These cards clearly indicate the contact information for the NWTMN. We would once again submit this information for your records.

It is very important for Paramount Resources to recognize the fact that there are only two Regional Aboriginal Governments (Deh Cho & NWTMN) involved in your EA process. The claims and involvement of the NWTMN in your EA process should not be viewed as a lesser in comparison to the Deh Cho. Since your development will occur on traditional Métis lands that are overlapped with the Deh Cho we would strongly advise your company to rectify this lack of communication immediately.

Finally, should the NWTMN be excluded either mistakenly or intentionally from any future meetings conducted by Paramount Resources, the NWTMN, will view this as disrespectful of our negotiations process and immediately lodge a letter of complaint to the Minister of Indian Affairs and Northern Development.

I look forward to your response and your efforts to correct this communication oversight.
