Thank you for your letter dated January 12, 2006, and your request that Canada refer Paramount Resource Ltd's Land Use Permit MV2005A0030 and Water Licence MV2005L1-0013 applications to the Mackenzie Valley Environmental Impact Review Board (the "Review Board") for environmental assessment.

Indian and Northern Affairs Canada (INAC) understands that the six wellsites in the above mentioned Land Use Permit and Water Licence applications, fall within the Planned Development Case of the approved Report of Environmental Assessment (EA03-005). As well, INAC concurs with the determination of the Mackenzie Valley Land and Water Board that Part V of the Mackenzie Valley Resource Management Act (the "Act") has been satisfied in respect to these applications.

INAC is therefore unable to proceed with your request for a referral to environmental assessment under Article 12 of the *Seulement Agreement* between the Deh Cho First Nations and the Government of Canada.

If you feel this proposed project could have an adverse impact on the environment of the Ka'a'Gee Tu's traditional territory, please provide written comments to the Mackenzie Valley Land and Water Board in accordance with its December 21, 2005 letter.
