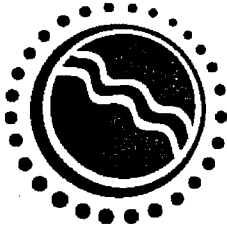
The Hearing agenda is still being finalized, as not all parties have confirmed their presentation time requirements. If you have not already done so, please indicate:
