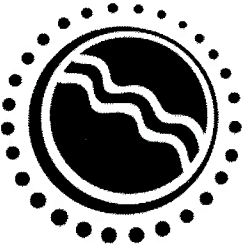

**Re: Notice of Referral to Environmental Assessment – Paramount Resources Ltd.
Cameron Hills Gathering System Expansion**

On May 28, 2003 the Mackenzie Valley and Water Board referred Paramount Resources Ltd's proposed expansion of the Cameron Hills Gas Gathering System to Environmental Assessment, according to section 125 of the Mackenzie Valley Resource Management Act. The Mackenzie Valley Land and Water Board cited a concerns over cumulative environmental effects and public concern as reasons for the referral.

Paramount Resources proposes to expand the existing gas gathering system in the Cameron Hills by 5 wells and 22 km of pipeline. The proposed development was part of Paramount's original Land Use Permit and Water Licence Application, but was not permitted by the Land and Water Board then. The proposed development includes:

- drilling of 5 wells,
- construction of production facilities at those wells,
- construction of 22 km of pipeline,
- maintenance of existing winter access,
- temporary camp sites
- water withdrawal from 3 lakes
- a remote sump, and
- 3 borrow pits.

The Review Board will initiate the scoping of the project and of the assessment shortly. Organizations on the distribution list will be invited to comment on a draft Terms of Reference and Work Plan. At a later date they will be asked to identify which role they intend to play during the assessment.
