# **Terms of Reference Section:**

#### Preamble

In Appendix C of the Community Investment Plan (DAR Appendix 7), the Deh Cho Bridge Corporation proposes to invest \$25,000.00 in a community organization to monitor social impacts and consider remedial actions as required.

However, in the consultation with the Fort Providence Inter Agency Group (DAR Appendix 8, p. 4) the feedback on the proposed Community Investment Plan is that the healthcare and social workers in the community are already working to the maximum capacity, and that the bridge construction will exacerbate the stress on the system.

### Request

- a) Which community organizations have been identified for the possible role of monitoring social impacts?
- b) What skills, qualifications and general desire is there on behalf of the organizations listed in a) to undertake this work?
- c) What social impacts will be monitored?
- d) What follow up is proposed, and by whom, to ensure that monitoring and remedial actions are appropriate and successful?

#### **Preamble**

The DAR (p.113) states that a spill occurring on the bridge would be more difficult to clean up and contain than a spill occurring on the ice. The DAR also states that the bridge design could incorporate features to facilitate spill containment and clean up?

# Request

- a) Does the current design of the proposed bridge incorporate the referred-to features to facilitate spill containment and clean up?
- b) If not, will the bridge design be altered to allow for the incorporation of features to facilitate spill containment and clean up?
- c) Describe the specific design features that will be incorporated to facilitate spill containment and clean up.

# Standard Format for MVEIRB Information Requests

Note: The purpose of Information Requests is to provide the MVEIRB with the information it needs to decide whether the proposed development is likely to have a significant adverse environmental effect. They are a tool for the Board to obtain additional information, clarification on issues, and to answer questions that arise during the proceedings of an Environmental Assessment.

Information requests can originate from and be directed at all parties to the assessment. A party that acts as an advisor to the Board, e.g., can request information that is necessary for that party's technical analysis of the Developer's Assessment Report. All Information Requests have to be approved by the Board.

#### Preamble

Provide background information and a rational for your request. The preamble should identify any shortcomings of the DAR and how the requested information will be relevant. For example: "The DAR describes various mitigation measures to minimize impacts on wildlife, but does not specify which measure is aimed at which species To determine the effectiveness of proposed mitigation measures the species they are aimed at should be known".

#### Request

The question the organization the request is directed to is to answer. For example: "Please identify which mitigation measures are aimed at minimizing impacts on moose". A question may consist of several parts.
