Re: EA0506-003 Ur Energy – Work Plan and Party Identification

Please find attached a work plan for the environmental assessment of Ur Energy's proposed uranium exploration program at Screech Lake.

The developer and the Lutsel K'e Dene First Nation (LKDFN) have been asked to provide additional information on the nature of their project and their concerns respectively. This information will be distributed as soon as it becomes available. The MVEIRB asks all organizations, or individuals, who may have information regarding any of the factors considered in the assessment, or regarding any of the concerns raised by the LKDFN, to provide this information to the MVEIRB at their earliest convenience but no latter than the date of the hearing.

The concerns raised by LKDFN involve:

- the cultural significance of the area;
- the importance of the area for hunting and fishing;
- potential impacts on the Beverly-Quamanurjuak caribou herd; and
- possible expansions of the Thelon Game Sanctuary and the proposed East Arm National Park.
