Re: Information Requests to the Yellowknives Dene First Nation

Dear Ms. Crapeau,

The Mackenzie Valley Environmental Impact Review Board (Review Board) is conducting environmental assessments of Consolidated Goldwin Ventures' (CGV) and Sidon International Resources Corp's (Sidon) mineral exploration programs. The Yellowknives Dene First Nation (YKDFN) has been a party to these environmental assessments since October 26, 2005.

On October 20, 2005, the Review Board issued Information Request to the Developers and to Parties to the environmental assessments. Specifically in the case of EA0506-005 (CGV), the Review Board issued IRs I.1-I.7 to the YKDFN and for the case of EA0506-006 (Sidon), the Review issued I.R. I.1 to the YKDFN. For your information, those IRs have been attached to this correspondence. In response to the issuance of those Information Requests, the Review Board received a letter from you, dated November 3<sup>rd</sup>, 2005, which indicated that the YKDFN was trying to respond to the Review Board's questions in preparation for the hearings that were to be held in December, 2005. Due to the inadequacy of the IR responses submitted by the Developers, the hearings were postponed indefinitely until the receipt of IR responses that would meet the Review Board's requirements and expectations.

In an effort to address the issue of outstanding Information Requests, and to move the environmental assessment process forward, CGV and Sidon have recently engaged the services of Rescan Environmental Services Ltd. A Rescan representative contacted the Review Board in early August to confirm their intentions to proceed on the environmental assessments. In light of this new development, the Review Board requests to know the YKDFN's intentions regarding its participation in the CGV and Sidon environmental assessments, and if possible, could it provide a timelines as to when the submission of the IRs issued to the YKDFN could be expected?
