Alistair

The summary of technical discussions (esp. hydrology and groundwater issues) looks fine to me.

Re your telephone inquiry in late August (received when I returned from vacation) - Do I wish to have information on possible surface impacts of groundwater dewatering by Cominco'c Pine Point Mine on area forests added to the public record for the Tamerlane project?

I do not know whether this is necessary, or appropriate, since information submitted concerns massive groundwater dewatering that is completely different than proposed for Tamerlane's Pine Point Project. I do not however have any objection to my August 22 email, my letter to you of July 19, 2007, and accompnaying documents being filed to complete the public record file on this matter, and therefore tried to provide as complete a package to you as possible for this purpose. Unfortunately, only incomplete extracts of relevant material were provided by library staff for the document(s) that they located, which should also be on file in the north.

From this material, it appears that the <u>documentation which best summarizes the conclusion that there were no demonstrated significant impacts of massive groundwater dewatering by Pine Point Mine on surface vegetation and groundwater conditions (and this should therefore clearly not be an issue for a Tamerlane project involving minimal groundwater dewatering) is contained in the <u>1984 evaluation of this issue by the NWT Water</u> Board Technical Committee for Cominco's Pine Point Mine.</u>

This technical report should be available in NWT Water Board files, though I am not aware whether files for projects decommissioned more than 15 years ago are readily available. You likely have better contacts with the NWT Water Board than I to request a copy of this document. If you would like me to prepare a formal letter (rather than an email) covering this, please advise me accordingly.
