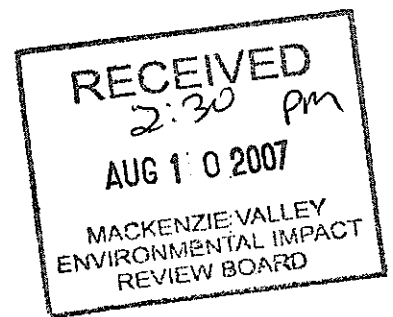

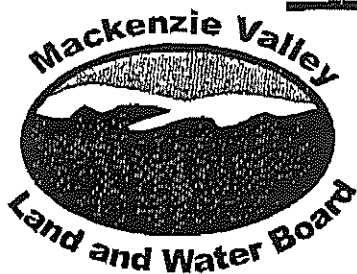
This decision stems from careful review and considerable discussion with membership that included clear expression of environmental concerns and the project's impact on our community.
