

## Re: Tamerlane Ventures

On behalf of the Chief and Council of Katlodeeche First Nation and its community members, I am writing to seek you support in moving the Tamerlane Pine Point Pilot Project ahead in an effort to promote the economic opportunities that will result with this mine going into operation.

Tamerelane commenced exploration activities in the fourth quarter of 2004 and completed a two-phase exploration program in the fall of 2005. In June 2006, Tamerlane Ventures acquired the remaining 40% interest in the Pine Point Property. Subject to receiving regulatory approvals, construction of the project would proceed in 2007 with the objective of advancing the project to a commercial production decision in as soon as possible.

The Tamerlane Pine Point project (PPP) proposes to demonstrate the economic viability of Pine Point by extracting of a one million tonne bulk ore sample from the R190 deposit zinc/lead deposit using a combination of basic and technical mining methods.

The mining of the bulk sample will entail the use of:

- Shaft sinking for orebody access,
- > Underground bulk mining methods for use in future mining of lower grade deposits,
- Freezing for groundwater control
- > Vertical conveyance for consistent hoisting of ore
- > Dense Media Separation (DMS) for upgrading low grade deposits.

The Katlodeeche First Nation has been developing a good relationship with Tamerlane over the past 2 years and has recently signed an agreement to work together on the Pine Point Pilot Project.

The agreement outlines job and business opportunities for the Katlodeeche people and ensures ownership in the project now and in the future.

Our agreement depends on Tamerlane obtaining its permits for this project, which as we understand, is on land that has been mined over 30 years in the past.

The permit process has already taken over a year and we are concerned for the opportunities of our people that it will take a lot longer. It appears to us there is little or no justification for the delay in awarding the permits as all terms and conditions set out by the Mackenzie Valley Environmental Impact Review Board were met or exceeded by Tamerlane Ventures.

As with ourselves, we know that the local communities are in full support of this project (See letter Attached) and would like to see the economic benefits sooner than later. We also have come to understand that it is not the communities holding this process up but the local government bodies out of Yellowknife.

It is clear to the chief & Council of the Katlodeeche First Nation that you, as Minister is very supportive of First nations building around economic infrastructure that will support the community in the future. KFN shares the same vision for our community and for the future of our youth.

We would appreciate any support that will help our community and others realize the economic benefits from the Pine Point Pilot Project sooner than later. We ask that you facilitate a meeting with our Chief and Council to discuss this matter further.
