Re: Notice of Referral to Environmental Assessment – Ur-Energy Inc.-Screech Lake (east of Great Slave Lake) Mineral Exploration.

On September 11, 2006 our office received the Mackenzie Valley Land and Water Board's referral of Ur-Energy Inc.'s proposed program at Screech Lake in the upper Thelon river watershed east of Great Slave Lake to Environmental Assessment, according to section 125 of the Mackenzie Valley Resource Management Act. The Mackenzie Valley Land and Water Board cited public concerns as reason for the referral.

The proposed development is of a similar nature as the development, by the same developer, subject to environmental assessment EA0506-003 last year. EA0506-003 was cancelled after the developer withdrew the land use permit application. The Review Board will review the EA0506-003 file as well as any additional information submitted with the new land use permit application and will provide a work plan.

The public record for EA0506-003 will be transferred to EA0607-003. Organizations or individuals who submitted comments for EA0506-003 but do no longer wish to have these considered by the Review Board should indicate this in a brief written statement.
