

INAC comments on the Draft Work plan and Schedule for the Environmental Assessment for Ur Energy Uranium Exploration Project Screech Lake (MVEIRB EA# 0607-003)

Comments on Specific Sections

Page 7 - Table 1- Constitutional issues

INAC would like to address the second paragraph which states, "The decision whether to actually allow the development rests with the Minister of INAC. The Minister will determine if consultation and accommodation were adequate for the Minister's purposes."

INAC is concerned that these sentences may create the impression that the Minister of INAC is the sole decision-maker in the context of EA's. Please note that s.130 of the MVRMA requires the Federal Minister and all of the Responsible Ministers (as defined in s. 111) to agree on a response to the Review Board's Report of Environmental Assessment. The Minister of INAC, as the Federal Minister, transmits this response to the Review Board on behalf of all the Responsible Ministers.

In addition, the Minister of INAC is not necessarily the only Crown representative involved in a pending decision which may attract the Crown's legal duty to consult.

This concern could be addressed by replacing "Minister of INAC" with "Responsible Ministers."

Page 7 - Table 1- Compliance with the Species at Risk Act

The last line in the last row is an incomplete sentence – some words may have been omitted.
