Re: Notice of Referral to Environmental Assessment – Selwyn Resources, Mineral Exploration at Howard's Pass (Selwyn Project)

NB: Selwyn Resources, Ltd. recently change its name from Pacifica Resources, Ltd.

You are hereby notified that Selwyn Resources' Land Use Permit application (S07C-003) for mineral exploration in the Howard's Pass area has been referred to Environmental Assessment (EA), pursuant to section 126(2)(b) of the *Mackenzie Valley Resource Management Act*. The project was referred by the Sahtu Secretariat Incorporated.

The project is a five-year, lead-zinc mineral exploration drill program, proposed over 24 week periods per summer season. The program is located in the Howard's Pass area, adjacent to the NWT/Yukon border and 330 km southwest of Tulita, NWT.

As per the requirements of MVRMA s.118(1), no license, permit or other authorization required under territorial or federal law for the undertaking of this development can be issued. The Review Board will create a public registry for this file, where all pertinent information will be held. The public registry will be available online at www.mveirb.nt.ca/registry. Details of the assessment process are described in the Review Board's Guidelines for Environmental Impact Assessment, available online at www.mveirb.nt.ca. Information on past EAs is available on the same site.
