Re: Application # S07C003 by Pacifica Resources Ltd.

The Sahtu Secretariat Incorporated Board of Directors had their meeting on June 7, 2007 in Tulita and there was a concern put forth from the Tulita District Land Corporation regarding Pacifica Resources Ltd.

We the Sahtu Secretariat Incorporated support the Tulita District Land Corporation to refer Pacifica Resources Ltd to go under an environment assessment according to our Sahtu Dene & Metis Comprehensive Land Claim Agreement under Chapter 25.3.4 which states:

"A development proposal in the settlement area or which may impact upon the settlement area may be referred for assessment to the Review Board by the Sahtu Tribal Council or any governmental authority, and by the Review Board on its own motion."

And under the MVRMA section 126 (2) (b):

"The Gwich'in or Sahtu First Nation, in the case of a development to be carried out in its settlement area or a development that might have an impact on the environment in that settlement area."

Therefore, we feel that the Tulita District requirements are not being met by Pacifica Resources Ltd. They require further work that needs to take place by the Tulita District
