Comment on draft Terms of Taltson Expansion: My name is William Schaefer Jr, I have trapped that area around the Taltson Hydro all my life and for the last 25 years both myself and son Ronnie trapped together on R.T.A (802).

The Taltson Hydro power house and all of the reservour is in the Centre of our trapline.

Now i myself have 45 years of observation of the existing Hydro operations of when the Hydro operated at maximum output in the days of the Pine Point Mine to less than half now.

The ice conditions now are treacherous with thin ice on Trudel and overflow on the taltson below the dam, when they operate at full capacity there was always thin ice conditions on Trudel and below the dam.

Every time we had to cross we had to check the ice everytime we crossed!!

You can cross the Taltson in the morning and when you come back to cross it doesn't mean you can cross in the same place that evening.

Now with the expantion of this new penstock and powerhouse and having both operating at full capacity the river system will change a lot because the river will only have shore ice and the rest of the river will be ice FREE all year round.

Therefore rendering our cabin on the taltson useless to us for trapping with no accessible means to cross. water can never hold up a ski-doo only ice.

One other regulation to keep in mind is the RENEWABLE RESOURCES POLICY ON COMPENSATION
