Please find attached Indian and Northern Affairs Canada's (INAC) response to IR #0809-002-01.

INAC has previously provided documents to MVEIRB concerning the regulatory processes in the 1990s. The Review Board's Note to File of November 24, 2008 lists all of these documents. The Review Board has chosen not to post some of these documents to the public registry on the basis that they are not directly relevant to the Request for Ruling. INAC has no objections to the Review Board's choice of relevant documents; we do wish to ensure, however, that all parties are aware of all the documents INAC has previously provided to the Review Board. We also note that one of the documents listed in the November 24 Note to File is described incorrectly: "Facsimile from San Andreas Resources Corporation to Environment Canada, September 29, 1993" should read "Facsimile from San Andreas Resources Corporation to Environment & Conservation [INAC], September 29, 1993" (correction bolded).

Request:

Provide for the Review Board's public record the following:

Any documents in your department's possession or readily accessible by your organization, not including those listed in Appendix 1, that may be of assistance to the Review Board in ruling on the appropriate scope of development for the Prairie Creek Mine EA. Indian and Northern Affairs Canada should spend special effort to locate documents listed in Appendix 2, given the department's lead role in previous environmental impact assessment and permitting in relation to the Prairie Creek Mine.

This request is not limited to submission of the documents listed in Appendix 2; the Review Board recognizes this is not an exhaustive list.

The Review Board is particularly interested in any documents that speak to the historic scope of development for the Prairie Creek Mine – both in relation to on-site infrastructure/nature of the proposed mining development and the structure and use of the winter road – as described in:

environmental impact assessment or baseline studies or reports,
Land Use Permits or Water License applications and supporting materials,
Any other correspondence related to these applications, and
Land Use Permits and Water Licenses themselves, including extensions or any authorizations made by other government departments or regulators.

In any case where Indian and Northern Affairs Canada was the actual regulatory authority for an application, and the relevant documents cannot be found, the Review Board would like reasons provided. Where only part of a document or submission can be located, this should be identified for the record.

The timeline for these documents, as far as the Review Board knows, goes back to approximately 1979 for any formal applications, and to 1975 for any environmental baseline studies.
