We respectfully request a ruling regarding the process for this particular EA and want to know why it is so different from every other EA we have participated in. Why is the process being modified and important aspects being left out? It is our understanding that the EA process normally includes: Community Scoping Sessions, Technical Sessions, Terms of Reference, Developer's Assessment Report, Information Requests and Public Hearing while in this particular EA process there is only: a comment deadline on a Workplan, one Community Information Session in only one community and then the Public Hearing? Although you have offered assistance for two (2) community members from other communities to attend the Community Information Session, this is also very confusing for us, how exactly can the MVEIRB gage the communities level of public concern while the public is not allowed to participate? We seriously doubt that Canada can fully assess the potential impacts to our environment utilizing this ad hoc, unproven, modified process and definitely will not be able to fulfill it's duty to consult and accommodate Akaitcho First Nations.
