RE: EA1415-01 CanZinc All-Season Access Road Impacts to Fish and Fish Habitat. Sundog Creek (Undertaking #7)

During the June 2016 Technical Sessions, Parks Canada Agency ("PCA"), Fisheries and Oceans Canada ("DFO") and the Canadian Zinc Corporation ("CanZinc" or the "Developer") committed to communicating on outstanding analysis and information requirements regarding fish and fish habitat loss/gain (including impacts of blasting) and associated monitoring (as outlined in Undertaking 7) to Liidlii Kue First Nation ("LKFN") and Dehcho First Nation ("DFN"). Further to this commitment the Canadian Northern Economic Development Agency's Northern Projects Management Office ("NPMO") encourages the LKFN and DFN to review the Developer's All-Season Road Supplementary Habitat Information, (Mackenzie Valley Environmental Impact Review Board ("MVEIRB" or "Review Board") PR# 299) which includes environmental baseline data on habitat within Sundog Creek and an unnamed creek both within the Nahanni National Park Reserve.

This report has assisted the Government of Canada in understanding fish and fish habitat along the All-Season Road alignment. Additional information requests have been submitted by PCA and DFO to seek further clarification from the Developer regarding potential impacts. The response to these information requests from the Developer, in conjunction with the report, will inform PCA and DFO views on the Project's impacts to fish and fish habitat and any further mitigation potentially required.
