Hey Laurie,

We agree, Commitment 10 should reference the WRRB instead of ECCC.

Suggested final wording:

The GNWT commits to providing the protocol outlining how boreal caribou collaring data were used for the TASR geotechnical investigations. The GNWT will provide new protocols for how boreal caribou collar data will be used during construction and operation of the TASR in the updated WMMP.

I've added "and operations" as the conceptual WEMP states under 1.0 Introduction (p.3):

"GNWT previously submitted a draft Wildlife Management and Monitoring Plan(WMMP) (version 1) with the project description to the Wek'èezhìı Land and Water Board WLWB) (Appendix M, PR#7) in March 2016 which <u>dealt primarily with the construction phase</u>. The following WEMP primarily addresses monitoring and management of impacts <u>related to the operational period of the road</u>, though several proposed programs August 03, 20174 will begin prior to construction in order to maximize the baseline dataset." (emphasis added)

and under 2.0 Objectives (p.4):

'The WEMP proposes monitoring during construction <u>and operation</u> of the TASR but, as part of adaptive management, the timelines proposed for individual monitoring programs will be continually re-evaluated as more information becomes available.' (emphasis added)

Understood that the discussion during the Tech Session focused on construction (and the geotechnical), but use of collar data is applicable to operations as well. Also, the number of collars found close to the proposed road during geotechnical suggested that collars may not provide the information that was initially desired (i.e. if no collared animals are near the road, it is difficult to adjust road-related activities based on collar data). The updated WMMP should recognize some of the limitations of collar data re: construction and operations, and provide approaches that address the limitations of the collar data (a good example of re-evaluation and adaptive management in practice).
