
I am writing to inform you that Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) would like to provide funding through its Northern Participant Funding Program in support of the Mackenzie Valley Environmental Impact Review Board's Scoping phase of the environmental assessment of Imperial Oil Resources Limited's proposed Norman Wells Waste Management Facility (EA2223-01). The intent of this funding program is to help Indigenous peoples and Northerners access the resources and expertise needed to participate effectively in impact assessments of major resource or infrastructure development projects in the North.

CIRNAC is inviting applications from individuals and groups seeking participant funding to take part in the Scoping phase of the environmental assessment of the Norman Wells Waste Management Facility for the 2022-2023 fiscal year, Applications will be accepted until 11:59 p.m. (MDT) Friday, July 27, 2022 (see attached Public Notice).
