Notice of Proceeding: Site Visit Opportunity

Depositing Processed Kimberlite into Pits and Underground, Diavik Diamond Mines

The Review Board would like to offer parties¹ to this environmental assessment an opportunity to participate in a site visit to Diavik Mine on **Wednesday, July 24, 2019**. The site visit is optional and does not affect participation in the environmental assessment proceeding. It is up to each party to decide if they want to take part in the site visit.

Site visit details:

- Up to 2 individuals from each party
- The Review Board will cover the cost of the charter from Yellowknife airport to the Diavik Mine and back. Parties are responsible for any other logistics and costs.
- Flight details
 - **Departure from Yellowknife: 8am**
 - Departure from Diavik Mine: 5:15pm

Each person who wants to participate must complete the following **by July 12, 2019**:

- Fill out the Review Board's Flight Waiver Form
- Fill out the Day Visitor Consent Form (for Diavik security clearance)

RELEASE, WAIVER AND INDEMNIFICATION

DAY VISITOR CONSENT FORM

1.0 Compliance with Diavik Diamond Mines Inc.'s (DDMI) Policies

1.1 I agree that I will abide by all DDMI policies and procedures that relate to conduct and activities at DDMI Sites.

4.0 Consent to Search and Surveillance

4.1 I acknowledge that DDMI prohibits the possession or use of illicit non-prescription drugs, alcoholic beverages, firearms or dangerous drugs by anybody, while on DDMI Sites, or while en route to DDMI Sites.

4.2 I acknowledge that DDMI prohibits the collection of rocks, minerals, antler, bone, timber and Aboriginal artifacts at all DDMI Sites.

4.3 I further acknowledge that DDMI enforces its policies and security procedures by conducting searches of persons or possessions, and surveillance of anybody at or around DDMI Sites including the use of closed circuit television and the use of electronic drug detection devices.

4.4 I freely consent to the search of my person, possessions and belongings and video surveillance of my activities when I am at DDMI Sites, the storage of such surveillance, and the use and disclosure by DDMI of the surveillance and related administrative notations for matters relating to security in accordance with DDMI Search and Surveillance policies and procedures (a copy of which is available on request).
