What are the objectives of this technical issues scoping meeting?



- to identify and **prioritize** issues to focus on in this EA
- to provide the Review Board with information that helps it write the best possible Terms of Reference
- to help the Review Board create a Terms of Reference that asks the right questions so Pine Point Mining can write a better Developer's Assessment Report



How can we achieve these meeting objectives?



You can use the information in the EA Initiation Package as a head start and then tell us:

- Do you agree with PPML's proposed most important issues to focus on in the scope of assessment? If not, what would you propose?
- Do you agree with PPML's proposed geographic and temporal scope of assessment for each valued component? If not, what would you propose?
- Do you agree with PPML's proposed methodology for assessing impacts on valued components? If not, what do you propose?



How much detail can we go into on each topic (aka staying out of the weeds)?



- Preparing a Terms of Reference is iterative. You will get other opportunities to provide more input.
- Not all differences on assessment methodology or specifics on what should be in the Terms of Reference can be resolved today.
- If discussion is taking too long, we will ask you to talk to each other separate from this meeting
- you can meet with Pine Point Mining to discuss effects assessment methodology or other matters and submit a meeting report

What belongs in the Terms of Reference? The following questions can help



- Is a given issue important enough be in the Terms of Reference? Why?
- Can it be better resolved or mitigated through routine regulations, or in another way?
- Could the impact be mitigated well enough with a standard regulatory authorization, without needing to be assessed?
- Is the effect from the project one that that could result in a significant adverse impact?



Think about an integrated systems approach to Mackenzie Valley environmental assessment

- Valued biophysical and human components of the environment are linked and integrated in the real world.
- Consider linkages between interconnected valued components when assisting us in preparing the Terms of Reference. How does your mandate fit into the big picture?
- We acknowledge that community meetings are needed to truly understand the values and worldview of people around the project area.



What will we do with the information you have given us today?



- We will prepare a draft Terms of Reference based on technical and community scoping meetings and the information in the EA Initiation Package
- We will give you the opportunity to review and submit recommendations on the draft Terms of Reference using the Online Review System
- We will prepare a final Terms of Reference along with a Scope of Assessment and Reasons for Decision
